Re: Reopener for Unknown Injury

Dear Interested Alaskan:

The 1991 agreement settling the federal and state governments' civil claims against Exxon contains a provision entitled "Reopener for Unknown Injury." If all of the specific requirements of the Reopener provision are met, Exxon could be required to make additional payments totaling as much as \$100 million to fund specific restoration projects identified by the governments to address injuries that meet the Reopener criteria. An information sheet describing those criteria is attached.

Whether or not the Reopener is pursued will be decided by the state and federal governments. The State of Alaska, in recognition of the importance of this issue to its citizens, has arranged public meetings in three communities for the purposes of explaining the requirements of the Reopener provision and soliciting information from the public regarding continuing natural resource injuries, and ideas for restoration projects to address those injuries. I will participate in these meetings along with Department of Environmental Conservation Commissioner Kurt Fredriksson, Ocean Policy Coordinator for the Alaska Department of Fish and Game Heather Brandon, and federal representatives. You have been identified for this mailing as someone who may be interested in contributing to this important process. Please feel free to distribute this mailing to anyone you believe may have valuable comments on this issue.
